- **Demonstration of Financial Need.** Please explain why you are requesting funds, illustrating your organization's financial need, noting specifically how and why the COVID pandemic has affected it. (2,000 characters) (30 points)
- **Use of Funds.** Please clearly explain your use of funds, in the "Explanation" column of your Budget Worksheet. (10 points)
